COMMISSION FOR CONCILIATION, MEDIATION AND ARBITRATION

TARIFF OF FEES

In terms of section 115(2A)(l) read with section 123(2) of the Labour Relations Act, No 66 of 1995, the Governing Body of the Commission for Conciliation, Mediation and Arbitration has repealed the Tariff of Fees published under Government Notice R216 of 23 March 2012 and established the following Tariff of Fees which will take effect on 1 April 2013:

TARIFF OF FEES

The Commission for Conciliation, Mediation and Arbitration may charge a fee in accordance with the tariff shown in Column 3 of Table 1 for the purpose listed in Column 2 of that Table. All fees **exclude** VAT.

147(5)	Resolving a dispute between parties to a collective agreement that provides for the resolution of that dispute by an accredited agency if the accredited agency's dispute resolution procedures are not operative.	R1 827 - R4 868 for each day or part thereof.



SCHEDULE

- (a) By the substitution in the Schedule to the Rules for item 200.04 of the following item:

"200.04 Customs and excise airports
(Section 6(1)(e) of the Act)

Bram Fischer International Airport
Cape Town International Airport
King Shaka International Airport
OR Tambo International Airport
Kruger Mpumalanga International Airport
Lanseria International Airport
Pilansberg International Airport
Polokwane International Airport
Port Elizabeth International Airport
Upington International Airport

Note:

Aircraft pilots requiring clearance at the above-mentioned airports (except OR Tambo International Airport, and in respect of scheduled international flights at Cape Town and King Shaka International Airports) at which no resident customs and excise officers are stationed, are required to give at least 12 hours notice of the time and date of their arrival or departure to the customs and excise office at the places mentioned, in order that arrangements may be made for the attendance of the necessary officers."

- (b) By the substitution in item 200.05 of the Schedule to the Rules for the words **"Bloemfontein International Airport"** of **"Bram Fischer International Airport"**
